Check Reorder	\$5.00	Charged when a client reorder checks (50 checks in a book)
HSA Account	\$35.00	Charged Annually
HSA Check Reorder	FREE	No Charge for HSA check reorder
Return Checks	\$20.00	Charged when a check is written/deposited and has insufficient funds
Stop Payment	\$20.00	Charged when a Stop Payment is placed on a check (per check)
Statements/Confirms/Tax Forms/Shareholder Reports Mailing Fee	\$50.00	Charged Annually if not on EDelivery*
Duplicate Mailing Statement	\$25.00	Charged when the client requests a duplicate statement to a designated person
Change of Address	FREE	No Charge to update Address
Overnight Check	\$25.00	Charged for FedEx delivery overnight
Incoming Wire	FREE	No fees for incoming wires
Outgoing Wire	\$15.00	Charged when funds are wired out of a client's account
Copy of Physical Tax Documents/Statements	\$5.00	Physically mailing out a document or statement (per statement or document)
Inactive Account Custody Fee	\$50.00	Charged when account has been deemed Inactive for a year (non-Qualified accounts only)
Mailgram	\$5.00	Charged when a mailgram is sent to the client. Mailgrams are sent by NFS for margin calls, debits, etc.
Traditional IRA, Roth IRA, SEP IRA or Simple IRA Maintenance Fee	\$35.00	Charged Annually
Conversion of Traditional IRA to Roth IRA	FREE	No Charge for this service
Trade Extension Fee	\$10.00	Charged when an account requests a Reg-T extension
529 Annual Maintenance Fee	\$20-\$25	Charged annually. Cost may vary depending on plan.

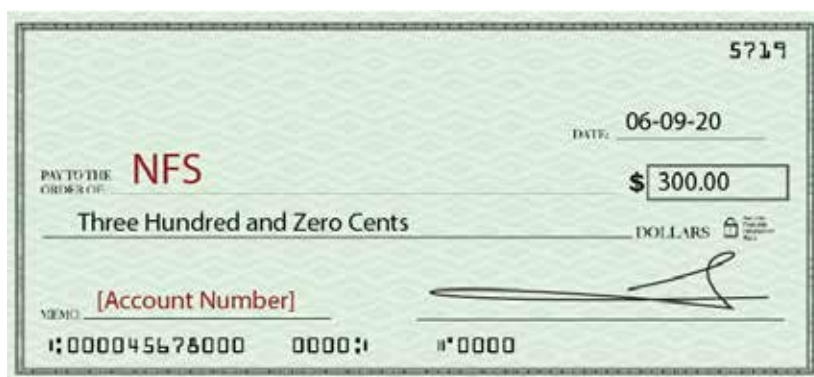

Description of Fee	Fee Amount	Additional Details
Transfer and Ship Fee (DRS Eligible)	\$65.00	Charge for sending a DRS statement for a DRS eligible security
Transfer and Ship Fee (non-DRS Eligible)	\$65.00	Charge for sending a physical certificate for a non-DRS eligible security
Safekeeping	\$5.00	Charged when a position is requested in a certificate form
Physical Reorg Fee	\$25.00	Charged when a stock certificate is deposited after the action date on a mandatory reorg item
Legal Return Fee	\$50.00	Charged when a stock certificate has been returned to client due to "not in good order" status for more than 45 days or at the client's request.
Transfer of Assets on Non-Qualified Accounts	\$50.00	Charge for transferring all assets out of an account
